Cover page

1. This tender name is changed to **Supply, Installation and Commissioning of 15 kV Class Metal-Clad Switchgear for Wakenaam Solar PV Project.**

Invitation for Bids (IFB)

1. The Guyana Power and Light Incorporated (GPL) invites bids from eligible bidders for the **Supply, Installation and Commissioning of 15 kV Class Metal-Clad Switchgear for Wakenaam Solar PV Project.**

Bid Data Sheet

1. ITB 1.1 is updated to indicate that the subject of procurement is **Supply, Installation and Commissioning of 15 kV Class Metal-Clad Switchgear for Wakenaam Solar PV Project.**
2. ITB 2.1 (f) is updated to indicate that the required warranty period is 36 months. This is now a specific warranty period that is required, not a minimum.
3. ITB 24.1 is added to indicate that a defects and liabilities period of one (1) year is required to cover the installation and commissioning works.

Special Conditions of Contract

1. GCC Clause No. 1:1 (c) is updated to indicate that the subject of procurement is **Supply, Installation and Commissioning of 15 kV Class Metal-Clad Switchgear for Wakenaam Solar PV Project.**

2. GCC Clause No. 6.1 is updated as follows:

Payment for Supply, Installation and Commissioning is as follows:

Payment will be as follows:

Advance Payment:

Thirty (30) percent of the Contract Price shall be paid within thirty (30) days of signing of the Contract, and upon submission of claim and a bank guarantee for equivalent amount valid until the Goods are delivered and in the form provided in the bidding documents or another form acceptable to the Procuring Entity.

On Delivery:

Forty (40) percent upon receipt of shipping document of the Contract Price of the Goods shipped shall be paid upon submission of claim (Air Waybill / BL).

On Acceptance after Installation and Commissioning:

Twenty-five (25) percent of the Contract Price of Goods delivered shall be paid within thirty (30) days of the Goods having been installed and commissioned supported by the acceptance certificate issued by the Procuring Entity.

After expiration of defects and liability period:

Five (5) percent of the Contract Price shall be paid within thirty (30) days upon expiration of defects and liability period.

Schedule of Requirements

3. The description column is updated to include further details to indicate more clearly to bidders what GPL requires to be procured. The switchgear technical specifications provided in the published tender document remain unchanged. See updated description below:

Supply, Installation and Commissioning of 15kV Class Metal-Clad Switchgear comprised of a total of nine (9) cubicles as indicated:

- a. Transformer Incomer Breaker cubicles (630 Amps), 3 units
- b. Outgoing Feeder Breaker cubicles (630 Amps), 2 units
- c. Bus Coupler Breaker cubicle (1250 Amps), 1 unit
- d. PT cubicles, 2 units

- e. Bus riser cubicle, 1 unit

Bid Delivery Schedule

- 4. "Description" is updated to "Supply, Installation and Commissioning of 15 kV Class Metal-Clad Switchgear for Wakenaam Solar PV Project".
- 5. "Name place of Destination as stated in the bid document" is updated to "Wakenaam GPL Power Station".
- 6. "Delivery Latest Date" is updated to "twelve (12) weeks after the signing of the contract or the receipt of the purchase order".

Evaluation Criteria

Phase one (1) of Evaluation – Mandatory Requirements No. 15 updated to "The switchgear as required in the tender document should have a minimum warranty period of at least 36 months. Provision of a signed statement of warranty for all items as specified here by GPL."

Notes on Evaluation (b) is updated to "The Contract would be awarded to the Bidder whose bid is determined to be substantially technically responsive to the Bid Document and who has received the highest points awarded."
