- 1. GPL is inviting bids for the sale and removal of its Plant and equipment at the Sophia Converter Station and the Kingston Steam Power Plant:**

### **Lot 1: Steam Power Plant**

Dismantling and safe removal of the demineralization plant, turbines and associated components of the Kingston Steam Plant.

*NB 1: ALL assorted metals extracted from the dismantling process are to be purchased and removed on an “as is, where is” basis.*

### **Lot 2: Converter Station**

Dismantling and safe removal of the Sophia Converter Station and all associated equipment.

*NB 1: ALL assorted metals extracted from the dismantling process are to be purchased and removed on an “as is, where is” basis.*

A bid Security of 2 % of the tendered sum *must* be submitted along with the bid.

Bids shall be valid for 90 days after the date of bid opening.
