GPL is inviting sealed bids for the purchase and removal of various types of scrap metal from the Garden of Eden and Versailles location on an “as is, where is” basis as follows:

- Lot 1 – Assortment of mixed metals and aluminum wires in the compound at Garden of Eden
- Lot 2 – Empty Metal Containers at Garden of Eden.
- Lot 3 - Decommissioned engines, alternators and an indeterminate amount of scrap metal in the compound at Versailles Power Station
- Lot 4 – Assorted scrap metal at Sophia, GT.

A bid Security of 2 % of the tendered sum *must* be submitted along with the bid.

Bids shall be valid for 90 days after the date of bid opening.

- Bids must be submitted with a valid **National Insurance Scheme (NIS) & Guyana Revenue Authority Compliance Certificate**. (*Only Applicable for locally registered company*)
- Bidders must bid for lot(s) in their entirety.
- Bidders can bid for any lot, multiple lots or all lots.
- The procuring entity reserves the right to issue one, multiple or all lots to one bidder or multiple bidders.

Terms & Conditions:

1. All Lots are sold on an “as is, where is” basis.
2. All Bidders **MUST** provide sufficient evidence of “registration with” and “certification by” **The Ministry of Tourism Industry and Commerce.**
3. Each Lot **MUST** be placed on individual bid forms.
4. Prospective Bidders are only allowed to submit one (1) bid per lot.
5. Bids for **LOT 3 MUST** include a removal plan inclusive of:
 - i. Timetable for various activities
 - ii. Evidence of access to or ownership of machinery/equipment to be used
 - iii. Method of Statement for the removal of scrap metals.
6. Prospective Bidders **MUST CLEARLY** indicate the lot on the bid form.
7. Payment of 100% must be made in cash or via manager’s cheque to Guyana Power & Light Inc by the successful bidder within **fourteen (14) working days** of written notification. Failure to pay within the stipulated period will result in the next ranked bidder being considered.
8. Scrap metals for the awarded lots **MUST** be removed within the subsequent **(fourteen) 14 working days** after payment is made.
9. Removal and transport of Lots from the location would be the responsibility of the bidder.
10. Successful bidders **SHALL** be held responsible for any oil spillage or damage to GPL’s property during the removal of Lots.
11. Successful bidders would be required to provide a list of employees who would be working at these respective locations.
