RFB Title: *Procurement of two (2) Motor Vehicles - 4x4 Double Cab Pickups*

1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. IDB-P1005989-06/22 of July 1, 2022.
2. The Government of the Cooperative Republic of Guyana has earned financing under the Guyana-Norway Partnership Agreement towards the cost of Guyana Utility Scale Solar Photovoltaic Program, and it intends to apply part of the proceeds of this financing to payments under the Contract for Procurement of two (2) Motor Vehicles - 4x4 Double Cab Pickups. The financing will be administered by the Inter-American Development Bank and procurement will be done pursuant to the Bank's Policies.
3. The Guyana Power and Light Inc. now invites sealed bids from eligible and qualified bidders for Procurement of two (2) Motor Vehicles - 4x4 Double Cab Pickups.
4. The Request for Bids will be conducted through the National Competitive Bidding (NCB) procedures specified in the Inter-American Development Bank's Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN2349-15, and is open to all bidders from Eligible Source Countries as defined in the Policies.
5. Inspection of the bidding documents will take place at the first address 10(a) given below from 08:30hrs to 16:00hrs Monday to Friday.

Qualifications requirements include (but not limited to) Business Registration/Incorporation documents, valid Guyana Revenue Authority and National Insurance Scheme Compliance Certificates, experience, financial capacity. Additional details are provided in the Bidding Documents. A margin of preference will not apply.
7. A complete set of Bidding Documents in English may be purchased by interested bidders at the address below and upon payment of a nonrefundable fee of three thousand Guyana Dollars (GYD3,000.00). The method of payment will be cash, check or direct deposit. The Bidding Documents will be delivered on a Flash Drive. It is the Bidder's responsibility to print the Bidding Documents.
8. Bids must be addressed, as instructed in the Bidding Documents, to the Chairman, National Procurement and Tender Administration Board and placed in the Tender Box at address 10 (b) below before 09:00hrs on December 7, 2023. Electronic bidding will not be permitted. Late bids will be rejected.

9. Bids will be opened at 09:00 hrs on December 7, 2023 during the National Procurement and Tender Administration's weekly opening of Bids. A link to the bid opening will be provided to bidders who may choose to participate. All bids must be accompanied by a Bid Security of GYD150,000.00 or an equivalent amount in a freely convertible currency.
